Revolvers & Pistols: Only sold to Delaware residents. Two Proofs of ID. Must be 21 years of age. **NOTE:** If you are **DELAYED** by the FBI, the wait period is now 25 days. If you are **DENIED** by the FBI, you **WILL NOT** receive your money back for the purchase. If you have any doubt whether you will be approved, we suggest you **DO NOT BID!**
