## GUNS


**All paperwork must be filled in immediately after the guns are sold  
so they may be called in on time.**

Due to FBI Regulations there will be a **\$25.00** charge on each gun purchased as well as a possible 25 day delay.

**If you purchase a shotgun:** You will need your driver's license.

**If you purchase a rifle:** You will need your driver's license and a second proof of identification such as your vehicle registration or an ID with your name and address. Must be 21 years of age.

**Revolvers & Pistols :** Only sold to Delaware residents. Two Proofs of ID. Must be 21 years of age.

**NOTE:** If you are **DELAYED** by the FBI, the wait period is now 25 days. If you are **DENIED** by the FBI, you **WILL NOT** receive your money back for the purchase. If you have any doubt whether you will be approved, we suggest you **DO NOT BID!**
